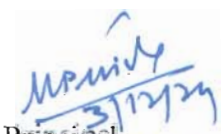

8. The legal jurisdiction of any dispute shall be within the city of Puri.

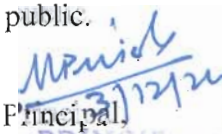
