As per the Govt. Order No. 35609/HE, Dt. 07.07.2025, Desirous Retired Govt. College Teachers (Professor/ Associate Professors/ Assistant Professor/ Readers/ Lecturers) who are below the age of 75 years, having Good Service Record and physically fit for engagement as contractual teachers and other eligible interested candidates for engagement as Head of the Department (Contractual) and Contractual Teaching Faculty at the **Department of Teacher Education, S.C.S. (A) College, Puri** only for the session 2026-27 depending upon vacancy/ requirement with remuneration as per Govt. norms.

The eligible interested candidates may attend Walk-in-Interview scheduled to be held on **01.08.2025 (Friday) at 11.00 A.M.** in the Department of Teacher Education of the college. The selection is purely based on State Government guidelines. Mere selection does not confer the joining of the candidate. The joining of the selected candidates is subject to approval from the State Government of Odisha.




